



## Terms and Conditions for bunq Google Ads Voucher Coupon promo

### 1. General

These rules are applicable to the promotional campaign "Google Ads Voucher Code promo" from bunq B.V. (hereinafter the "promotion"). The promotion is intended to promote the use of bunq Business account

### 2. Participation

- 2.1. Do you want to participate in the promotion? If so, please continue reading.
- 2.2. By participating in the promotion, you accept and agree to these rules.
- 2.3. In order to receive the promotional code, you have to activate a Business account with bunq during the promotion period. After your account is fully approved you will receive an email with your code.
- 2.4. Offer available to customers with a billing address in residents of Austria, Belgium, France, Germany, Ireland, Italy, The Netherlands, Portugal, Spain, and who are 18 years or older during the entire promotion period. One promotional code per advertiser.
- 2.5. **To activate this offer:** Enter the promotional code in your Google Ads account before 31 December 2020. In order to participate in this offer, you must enter the code within 14 days of your first ad impression being served from your first Google Ads account.
- 2.6. **To earn the credit:** Start advertising! The advertising costs you accrue in this account in the 31 days following your entry of the promotional code, excluding any taxes, will be matched with an advertising credit in the same amount, up to a maximum value of €120.
- 2.7. Once 2 and 3 are completed, the credit will typically be applied within 5 days to the Billing Summary of your account.
- 2.8. Credits apply to future advertising costs only. Credits cannot be applied to costs accrued before the code was entered.
- 2.9. You won't receive a notification once your credit is used up and any additional advertising costs will be charged to your form of payment. If you don't want to continue advertising, you can pause or delete your campaigns at any time.
- 2.10. Your account must be successfully billed by Google Ads and remain in good standing in order to qualify for the promotional credit.
- 2.11. bunq employees and other persons directly involved in organizing this promotion are excluded from participation in the promotion.
- 2.12. Your participation in the promotion will immediately end if you cancel your bunq account or (any of) your bunq account(s) gets (temporarily or permanently) blocked.
- 2.13. We will exclude you from participation in case: (i) we know or suspect you misuse(d) our services, (ii) we believe that you acted in conflict with the goal of the promotion or (iii) if we believe you (tried to) damage(d) our reputation.

- 4.1. Participating is at your own risk. We accept no liability for damages of any kind whatsoever resulting from your participation in the promotion.
